Vehicle History

- Check the Car's History: Use the [NZ Transport Agency's \(NZTA\) Motor Vehicle Register](#) to get the car's history, including ownership, odometer readings, and any reported accidents.



Pre-Purchase Inspection

- Get a Pre-Purchase Inspection: Have the car inspected by a professional mechanic to check for any hidden issues. Trusted providers include VTNZ and AA New Zealand.



Test Drive

- Schedule a Test Drive: Test drive the car to check its performance, handling, and comfort. Listen for unusual noises and pay attention to how it drives.



Negotiation

- Negotiate the Price: Use your research on market value to negotiate a fair price with the seller.
